- Overall Processing Time reflects mariners' experience
- ➤ 6,840 applications outside of NMC control (not included in inventory above)
 - ❖ 3,602 Awaiting Information (AI)
 - ❖ 3,238 Approved to Test
- > MMCs issued in August 63% were in Al at one point




MMC Processing






MMC Backlog

SSEB Inventory and State Cycle Time by Month






MMC Endorsements By Year




Med Cert Processing

Total Med Cert Applications Received





Medical Certificate Bulletin

- ➤ Processing times increased due to large e-mail volume

 ☐ Multiple emails for same app create delays
 - ☐ 25% of emails were duplicates
 - □ 9% of applications were incomplete and rejected
- Email Med Cert apps to MEDAIP@uscgmil
 - ☐ Subject line: LAST NAME_FIRST NAME_MRN
 - ☐ Name PDF the same
- >Submit as one PDF other formats not accepted

Medical Division

The Medical Division is responsible for determining the medical fitness for mariners to serve in the capacities specified by the domestic and international endorsements for which they apply.

To qualify for a medical certificate, a mariner must provide evidence of meeting the medical and physical standards on a CG-719-K or CG-719-K/E, as appropriate..

Medical Certificate

The medical certificate is a document that serves as proof that a mariner meets the <u>required medical and physical standards</u>. In order to receive a Merchant Mariner Credential or Medical Certificate you will need to complete the correct applications.





Compliance Investigations Team

- Fraud = something in the application was submitted that was verified not truthful
- Non-compliance = the mariner served in a vessel position without the proper endorsement

Compliance Investigations Team

Top 5 reasons apps sent to CIT

- Duties do not match endorsement
- DE/QA not approved for the task
- Vsl ownership not proven when attesting to service
- Change from previous SS letter
- No breakdown of service

Frequent Fraud/Non-compliance Cases Proven

- Falsifying SS records
- Falsifying TOAR sign-offs
- Forging Course Certificates
- Working in positions not authorized
- SS doesn't comply with COI requirements





External Audit Program

Program Focus

- Compliance w/ approved course curricula
- Practical assessment execution
- Availability and condition of approved equipment
- Instructors and sites are approved and sufficient
- Timely correction of non-conformities





Actions Resulting from Audits

1 Jan - 17 Aug 2024:

- 34 Courses moved to Intent to Suspend (3 Training Providers)
- 35 Courses Administratively Withdrawn (3 Training providers)



- Mariners holding resulting endorsements were notified of options to retain them
- Applications from non-compliant mariners are rejected
